TEXT ORDER. A fairness hearing is scheduled in this case for 8/12/2022 at 10:30 AM. At the 6/14/2021 fairness hearing, the Court raised the issue of standing with the parties. (See Doc. [70] at 14-19). On 7/27/2022, the Eleventh Circuit published *Drazen v. Pinto*, -- F.4th --, 2022 WL 2963470 (11th Cir. July 27, 2022), which may impact whether standing exists. Given the potential impact of the Eleventh Circuit's decision, the Court will require supplemental briefing. No later than 8/8/2022, the parties must *separately* file supplemental briefing - of no more than 10 pages each - addressing: (1) the effect, if any, *Drazen v. Pinto*, -- F.4th --, 2022 WL 2963470 (11th Cir. July 27, 2022), or any case cited therein, has on this case; and (2) whether the Court still possesses jurisdiction over this action. Additionally, the parties must be prepared to address the same at the 8/12/2022 fairness hearing. Finally, the parties are ORDERED to post this Order as well as both supplemental briefs on the settlement website no later than 8/8/2022. Signed by Magistrate Judge Mac R. McCoy on 7/29/2022. (CM)
