**TEXT ORDER.** The pending motion for final approval of class settlement was filed on 6/9/2022. (Doc. [84]). In the motion, Plaintiff represents that the Settlement Administrator did not receive any requests for exclusions or objections, but that the deadline for both was 7/13/2022. Because the operative deadline lapsed after Plaintiff last updated the Court, the Court will require the parties to provide a further update before the fairness hearing. Accordingly, no later than 8/10/2022, the parties must file a joint statement of no more than 5 pages, supported by an affidavit from an authorized representative of the Settlement Administrator, stating whether any requests for exclusions or objections were timely or untimely received. The parties must be prepared to address the same at the 8/12/2022 fairness hearing. Finally, the parties are ORDERED to post this Order as well as a copy of their joint statement on the settlement website no later than 8/10/2022. Signed by Magistrate Judge Mac R. McCoy on 8/1/2022.
