Plaintiff Daryl Teblum and Defendant Physician Compassionate Care, LLC d/b/a DocMJ (jointly, the “Parties”), hereby provide the following Joint Status Report to this Court in compliance with this Court’s August 1, 2022 Text Order (Doc. 86), and in support thereof state as follows:

1. On March 7, 2022, this Court entered an Order (the “Order”) which approved the deadlines contained in Plaintiff’s Renewed Consent Motion for Approval of Renewed Proposed Notice and Objection Procedure (the “Motion”) (Doc. 79) and set a Fairness Hearing for August 12, 2022. (Doc. 82).
2. Pursuant to the Motion and Order, the deadline for Settlement Class Members to submit an exclusion was July 13, 2022.

3. Pursuant to the Motion and Order, the deadline for Settlement Class Members to file an objection was July 13, 2022.
